### OBJECTIVES, ROLES AND RESPONSIBILITIES OF INTERNAL COMPLAINTS COMMITTEE

- Prevent discrimination and sexual harassment, by promoting gender amity among students and employees;
- Make recommendations to the management for changes/elaborations in the Rules for students in the Prospectus and the Bye-Laws,
- to make them gender just and to lay down procedures for the prohibition, resolution, settlement and prosecution of acts of discrimination and sexual harassment, by the students and the employees;
- Deal with cases of discrimination and sexual harassment against women, in a time bound manner, aiming at ensuring support services to the victimized and termination of the harassment;
- Recommend appropriate punitive action against the guilty party to the Management.

Here it should be noted that according to the Supreme Court guideline Sexual harassment can be defined as "unwelcome" sexually determined behavior (whether directly or by implication) as:

- 1. Physical contact and advances;
- 2. Demand or request for sexual favors;
- 3. Sexually colored remarks;
- 4. Showing pornography; and
- Other unwelcome physical, verbal or non-verbal conduct of a sexual nature. (Vishaka judgment by Supreme Court)

The following is also sexual harassment and is covered by the committee:

- Eve-teasing
- Unsavory remarks,
- Jokes causing or likely to cause awkwardness or embarrassment,
- Innuendos and taunts,
- Gender based insults or sexist remarks,
- Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls) and
  the like, Touching or brushing against any part of the body and the like, Displaying pornographic or
  other offensive or derogatory pictures, cartoons, pamphlets or sayings, Forcible physical touch or
  molestation and Physical confinement against one's will and any other act likely to violate one's
  privacy.

The Committee shall meet as often as may be needed and appropriate.

Frequency of meeting: Once in a year (beginning of academic year) and as and when necessary

#### Responsibilities:

The Internal Complaints Committee (As per section 4 of Sexual Harassment of Women at workplace - Prevention, Prohibition and Redressal Act, 2013 ) for 2019-2020 is constituted. The duties and Responsibilities of the Internal Complaints Committee are as follows:

- The Committee shall consider the Welfare of Women Teaching and Non-teaching Staff members of the college.
- 2. The Committee shall consider the recreational facilities to lady staff.
- 3. The Committee shall create the health care facilities to lady staff members and Girl students.
- The Committee shall review the complaints if any received from lady staff members and girl students and take appropriate action.

The Committee shall meet as and when required and the minutes of the meetings may be recorded.

# Responsibilities of Internal Complaints Committee

The Internal Complaints Committee (As per section 4 of Sexual Harassment of Women at workplace - Prevention, Prohibition and Redressal Act, 2013) for 2023-2024 is constituted. The duties and Responsibilities of the Internal Complaints Committee are as follows:

- The Committee shall consider the Welfare of Women Teaching and Non-teaching Staff members of the college.
- The Committee shall consider the recreational facilities to lady staff.
- 3. The Committee shall create the health care facilities to lady staff members and Girl students.
- 4. The Committee shall Receive complaints of sexual harassment if any from lady staff members and girl students Initiate and conduct an inquiry. Submit findings and recommendations of all such inquiries and take appropriate action.
- Maintain strict confidentiality throughout the process as per established guidelines of the Internal Complaints Committee Policy. Submit annual reports in the prescribed format as prescribed.
- The Internal Complaints Committee is required to be vigilant to redress the sexual harassment complaints and resolve the same ASAP.
- In case of allegations are not in the nature of sexual harassment, ICC may refer such complaints to the Grievance Redressal Cell.
- 8. If ICC concludes that the allegations made were false, malicious or the complaint was made knowing it to be untrue or forged or misleading information has been provided during the inquiry, the complainant shall be liable to be punished as per the relevant provision of the aforementioned UGC Regulations 2015.
- 9. Submit annual reports in the prescribed format as prescribed

The Internal Complaints Committee is required to be vigilant to redress the sexual harassment complaints and resolve the same ASAP.
