VISION:

To oversees the effective implementation of policies and programmes for the needy groups and to act as source of strength by providing Psychological and monetary assistance in order to achieve equality and social justice.

MISSION:

- To provide opportunity and facilitation to the deprived groups for learning and creating space for them to mainstream themselves.

INTRODUCTION:

The SC/ST Cell, a statutory body has been constituted by the Ministry of Human Resource Management (MHRD), Government of India (GOI) in the erstwhile BEC to safeguard the interests of the SC/ST students and employees of the Institute as per the instructions of MHRD, GOI from time to time.

The main aim of the Cell is to monitor the guidelines issued by the University Grants Commission and by the department of Ministry of Social Welfare Government of Andhra Pradesh from time to time.

To see that all the directions given by the Government, Central, State and U.G.C in their circulars Issued from time to time in respect of reservation are strictly followed.

To see that possible necessary facilities like Hostel, Scholarships, Reservation fellowships, Book facilities etc. Provided by the central and State Government, reach the SC/ST candidates

The SC/ST Cell activities are:

- The SC/ST Cell has taken up the problems of the SC/ST students and employees with the university authorities and has solved some of them amicably.
- The cell, in the ultimate analysis, has been a user-friendly counselor to all SC/ST employees and students

UGC GUIDELINES FOR THE SPECIAL CELL SC/ST STANDING COMMITTEE:

The SC/ST Standing Committee ensures the effective implementation of the policies and programmes of the Government of India, UGC and State Governments with regard to backward castes, classes and physically challenged. It also suggests measures for achieving the objectives laid down by the various government agencies. The Committee meets at least two times in a year and the decisions arrived at is mandatory to be implemented. The Committee functions under the Chairmanship of the Director.

ESTABLISHMENT OF SC/ST

Gouthami Instutute of Technology & Management for Women, Proddatur, had set up a special cell in August 2018 to assist the students from Scheduled Cast (SC) and Scheduled Tribe (ST) communities in improving their academic performance and in optimizing their development in their personal and social life at the Affiliate Colleges as per the guidelines of UGC/AICTE for strict implementation of reservation policy in University and its Affiliated Colleges.

THE MAIN OBJECTIVES OF THE SC/ST CELL ARE AS FOLLOWS:

- To implement the reservation policy for SCs/STs in the College.
- To collect data regarding the implementation of policies in respect of admissions.
- To implement, monitor and evaluate continuously the reservation policy in the university/Affiliate Colleges and plan measures for effective implementation of the policy and programme of the Government and UGC.
- To guide the SC/ST students of the college, to optimally utilize the benefits of the schemes offered by the State Government, Government of India (GOI) and UGC.
- Functions of SC/ST CELL
- To circulate State Government and University Grants Commission's decision and to collect regularly, on an annual basis, information regarding course-wise admissions to candidates belonging to the Scheduled Castes/Scheduled Tribes in the college for different courses, in forms prescribed by a stipulated date and to take follow up action, where required.
- To circulate State Government and University Grants Commission's decisions and to collect information in respect of appointment, promotion, training of these communities in teaching and non teaching posts in the Universities and Affiliated Colleges, in suitable forms by a stipulated date and take follow up action where required.
- To analyze the information collected above and prepare reports and digests for onward transmission to the Ministry of Human Resource Development/University Grants Commission and such other authorities as may be required.
- To deal with representations received from Scheduled Castes/Scheduled Tribes candidates regarding their admission, recruitment, promotion and other similar matters in Universities/Affiliated Colleges.
- To monitor the working of the remedial coaching scheme, if approved in the affiliated colleges and university.
- To function as a Grievances Redressal Cell for the Grievances of SC/ST students to render them necessary help in solving their academic as well as administrative problems.
- To counsel and guide SC/ ST students and help them to manage academic and personal issues of college life effectively.

LIAISON OFFICER (SC/ST & OBC CELL)

The Scheduled Castes/Scheduled Tribes Cell was established in the college as per Government and UGC directions in the year 2018. The honorary position of the Liaison Officer is occupied by Mrs. M. Karuna Jyothi, Associate Professor, H&S. The Liaison Officer, on behalf of the Cell, facilitates the overall welfare of the students, staff and faculty belonging to these communities. However, the responsibilities of the Liaison Officer are briefly given below

RESPONSIBILITIES TOWARDS STUDENTS:

The Liaison Officer on behalf of the SC/ST Cell organizes pre-admission coaching programme for SC/ST candidates to help them prepare for Entrance Tests as well as Post-admission orientation programme for new students at the beginning of the academic session. Various coaching classes are conducted on life skills, personality development, writing and presentation skills and so on. Interactive sessions and informal meetings with students are also conducted to help them deal with personal, social and academic problems.

ADVISORY COMMITTEE OF SC/ST CELL

The SC/ST Cell Advisory Committee ensures the effective implementation of the policies and programmes of the Government of India, UGC, AICTE and State Governments with regard to SC/ST and other backward classes. It also suggests measures for achieving the objectives laid down by the various government agencies. The Committee meets at least two times in a year and the decisions arrived at is mandatory to be implemented. The Committee functions under the Chairmanship of the Hon'ble Director.
