3) **MEMBERSHIP:-**

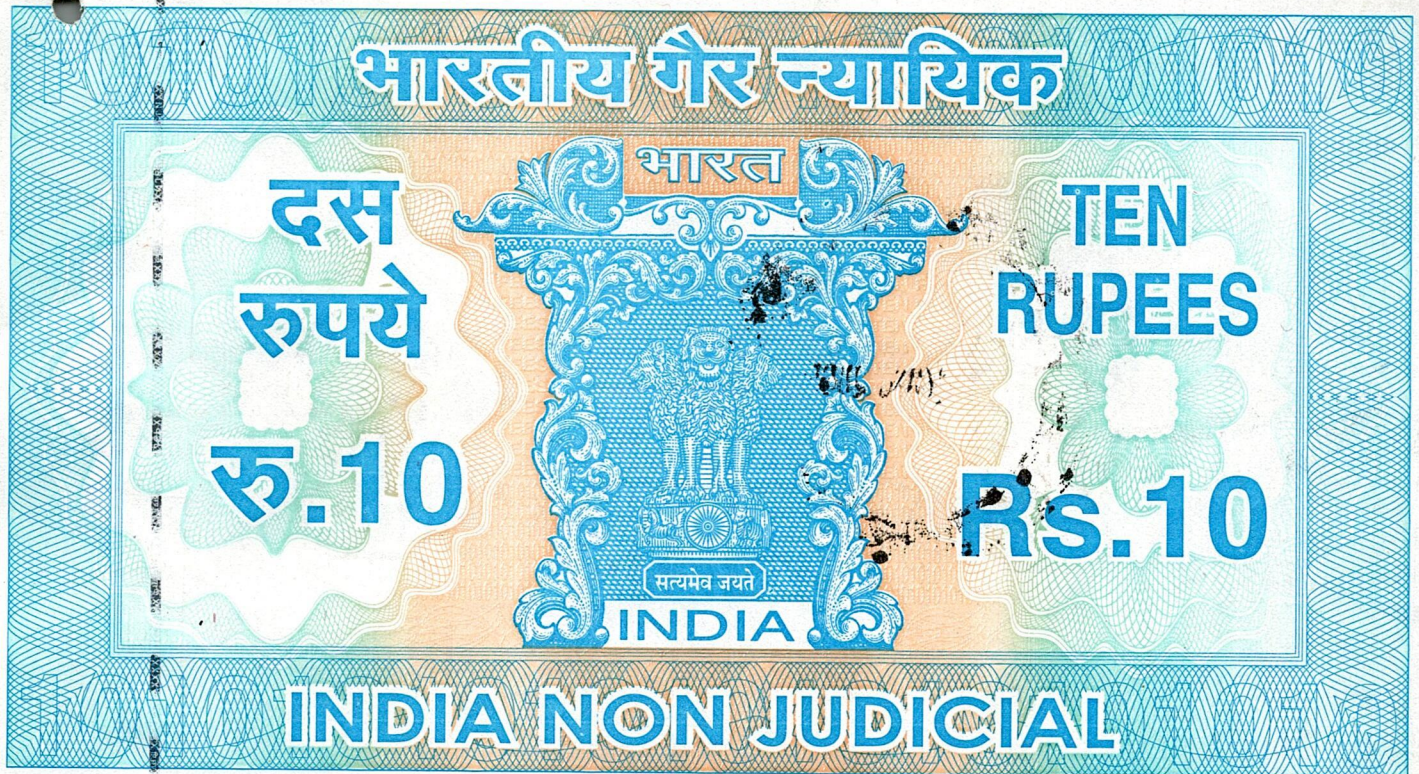
- a) Any person after attaining the age of 18 years is eligible to become a member of Association on payment of Rs. 10/- as admission fee and apply in writing to the President.
- b) Every member of the Association shall contribute a monthly subscription of Rs.10/-. If any member fails to pay the contribution for 3 consecutive months; his name will be deleted from the membership. But such member will be re-admitted on payment of arrears of the subscription and after assigning satisfactory reasons. The Association has got the right to admit or reject any applications without assigning any reasons.

4) **GOVERNING BODY:**

The Management of the Association will be entrusted to the Committee consist of a President, Vice-President, Secretary-cum-Correspondent, Treasurer and (5) EC Members in total (9) Nine. The present committee members will hold office for a period of ONE year.

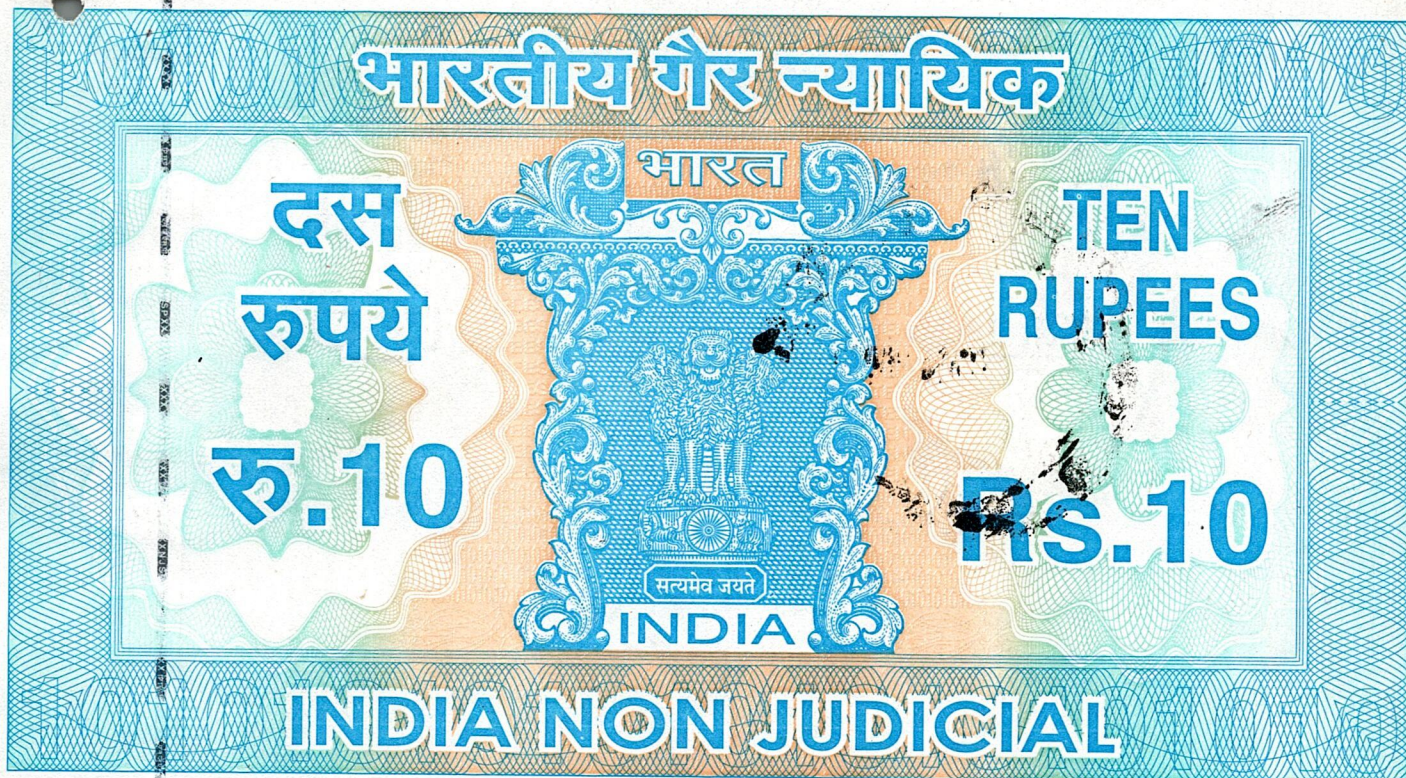


5) MEETINGS:

- a) **General Body Meeting** : The Association shall convene a General Body Meeting once in a year preferably in a month of April. All the matters connected with the affairs of the Association shall be discussed and decided in the meeting. The election of the office bearers shall also be conducted in the meeting. The quorum of this meeting shall be 1/2 of the members on Roll
- b) **Governing Body Meeting** : The Meeting of the Governing Body shall be convened at least once in a month, in case of necessity the committee shall conduct when ever necessary. The quorum of this meeting shall be 1/2 of the members on Roll. Any interim vacancies that will fall due to death or resignation will be filled up by co-option till next Elections.
- c) **Special / Extra Ordinary Meeting** : On special cause being shown, the Association or 3/4th members of the total members can call for special or extra ordinary General Body Meeting by a written notice 7 days in advance all such notices shall be served to all the members as far as possible mentioning the purposes for which the meeting is called for only the business specified in the notice shall be conducted in the meeting subject to the provisions of section 12 of the Society Registration Act. The quorum of the meeting shall be 3/5th of the members on the Roll.

6. **DUTIES OF THE OFFICE BEARERS :**

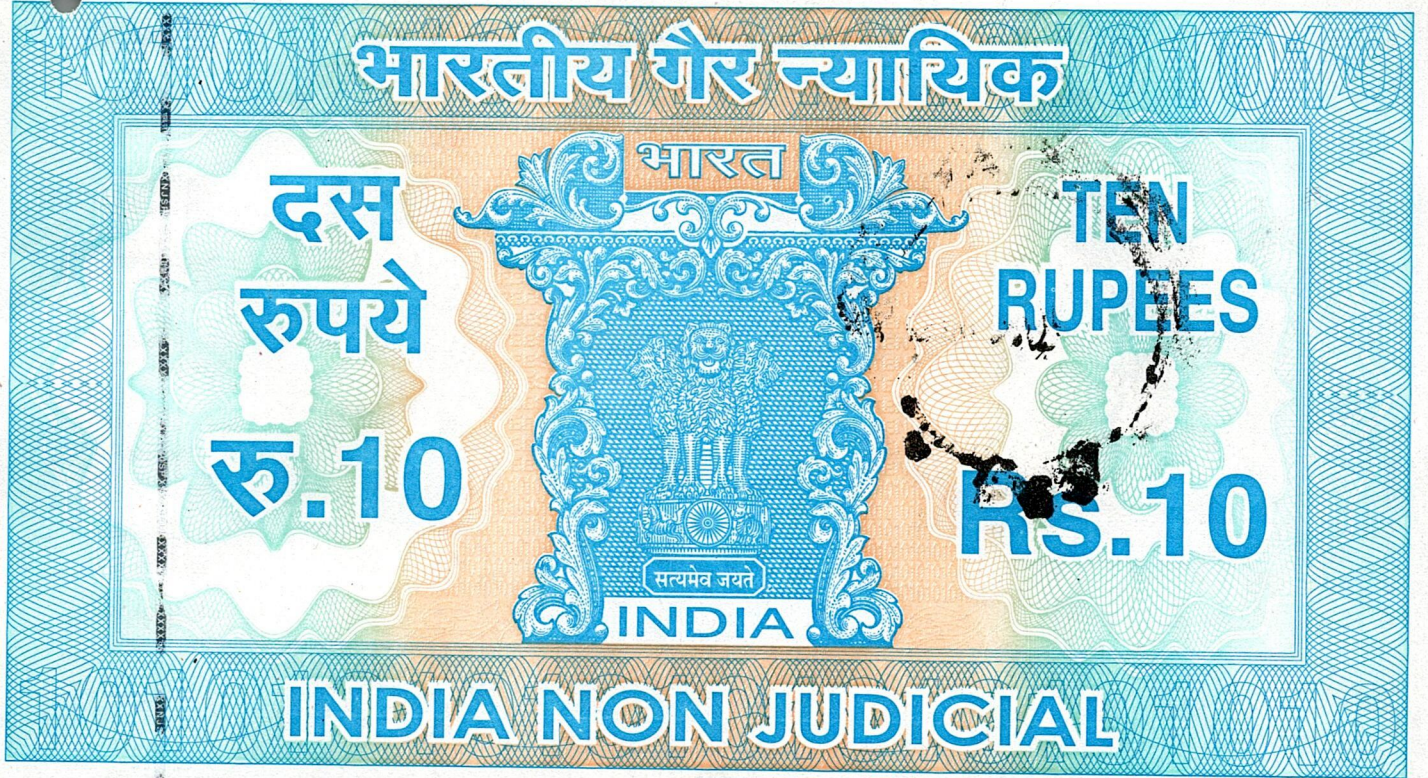
- a) **President:-** The President as far as possible shall preside over all the meetings and supervise the affairs of the Association in General. The President has a casting vote. If the quorum is not achieved in any of the meeting the President will use his/her casting vote and get the resolution passed.



- b) **Vice President :-** He/She shall carry out such of the duties as or entrusted by the President in his/her absence.
- c) **Secretary-cum-Correspondent:** He/She shall manage the affairs of the Society. He/She shall arrange all the meeting. He/She shall manage the income expenditure accounts, grant receipts under his signature obtain voucher for the amount spent. He/She shall correspondent all the matters relating to the Society. He/She shall supervise and maintain the property if any in the name of the Society. The Secretary-cum-Correspondent shall have powers to appoint staff if necessary fix their salaries for the up-keep of the Society. The Secretary-cum-Correspondent shall also have powers to punish, dismiss the staff so appointed for the mis-conduct and mis-behaviour. He/She shall get the Accounts Audited by the Auditor.
- d) **Treasurer :-** He/She shall collect all the subscription, donations relating to the Society. He/She shall grant proper receipts for the collection of subscription and donations. He/She shall be in charge of the funds and he is responsible for all the amounts collected on behalf of the Society. The amounts so collected shall be deposited in any Nationalized Banks or Post Office Accounts in the name of the Society and shall be drawn if necessary under the Signature of President and Secretary-cum-Correspondent only.
- e) **Members :-** They shall assist the President for the smooth running of the Society.
